Any and all notices to Alameda Electrical Distributors, Inc. and/or California Service Tool, Inc., to the Guarantor or to the firm shall be mailed, postage prepaid, the addresses herein set forth or to such other addresses as they shall designate by written notice to the others. Notice shall be complete on personal delivery or the deposit of notice in the United States mails.

Costs of court confirmation of the arbitration award after it is rendered by the arbitrator, shall be paid to the prevailing party by the party designated by the arbitrator or Court. Should a party dismiss his/her claim, the other party shall be designated the "prevailing party". Service of all notices and pleadings required in the arbitration or court enforcement of same shall be by first class prepaid mail.
